CONTRACT

Cedars Edge Golf Course, West Branch, Iowa

This contract shall extend from April 1st, 2022 to March 31st, 2023.

The golf course will be open daily, weather permitting.

Birdies Eats & Drinks as well as Cedars Edge Clubhouse and golf simulator will be open year round to the public.

Cedars Edge Golf Course is a nine hole course offering the use of the nine, plus a putting green and everyday normal use of the clubhouse. The clubhouse may be rented for other uses on occasion, which do not interfere with normal golf activities but as a member we are offering discounted fees. All food and alcoholic beverages must be purchased at Cedar Edge or Birdies.

State law prohibits any alcoholic beverages to be brought on or taken from the premises.

NO EXCEPTIONS

Iowa law requires that we sign a contract with those of you purchasing a golf course membership. The intention of the law is to eliminate fraud and to spell out how you may escape or receive a refund on your membership in the event of death or disability that would preclude the use of your membership.

Owner may allow membership refunds on a pro-rated basis if ill health or other unforeseen circumstances preclude its full use. Any refunds will be based on the judgement of the owner of Cedars Edge Golf Course.
